# **COACHING AGREEMENT**

Any dispute, controversy, or claim arising out of or relating to this Agreement or the breach thereof, shall be settled by binding arbitration in accordance with the rules of the American Arbitration Association. The arbitration will take place in Michigan, and the arbitrator's decision shall be final and binding. Judgment on the award rendered by the arbitrator may be entered in any court having jurisdiction thereof.

# 8. Media Release and Reference Agreement

The Client agrees to provide a reference for the Coach upon request, whether in writing, over the phone, or through a testimonial. The Client also consents to the use of their name, likeness, voice, and/or written testimonials in marketing materials, including but not limited to print, online, and video media, without compensation or further approval.
